

TÜRK TRAKTÖR VE ZİRAAT MAKİNELERİ ANONİM ŞİRKETİ
THE INFORMATION TEXT ON THE PROTECTION AND PROCESSING OF PERSONAL DATA
REGARDING THE SUPPLIER PORTAL

Pursuant to the Law No. 6698 on the Protection of Personal Data (“**Law**”), your personal data in the categories of Identity, Communications, Finance, Audit and Inspection, Transaction Security, Legal Process and Compliance Information may be processed by Türk Traktör ve Ziraat Makineleri A.Ş. (“**Türk Traktör**” or “**Company**”) as data controller within the scope explained below.

Processing of Your Personal Data, Legal Basis, and Purposes of Processing

Your personal data collected shall be processed by the Company within the scope of supplying goods or services from you or your employer to our Company for the following purposes (“**Purposes**”) within the personal data processing conditions specified in Article 5 of the Law.

- To obtain and evaluate the necessary information for supplier application procedures,
- To negotiate in order to establish a supplier relationship with our Company,
- To enter into a supplier relationship between our Company and you or your employer,
- To fulfil the obligations arising from the supplier relationship between our Company and you or your employer,
- To register your user profile in the Türk Traktör Supplier Portal (“**Portal**”) created by our Company so that you can use the Portal on behalf of the relevant supplier, user management of the Portal, to record transactions carried out through the Portal,
- Execution of the payments,
- Audit processes of our Company,
- Corporate governance and sustainability activities of our Company,
- Management of legal processes.

The Parties Your Personal Data Transferred to and Purposes for Transfer

Your personal data collected, in line with the above-mentioned Purposes, shall be transferred to Koç Holding and its affiliates, banks, legally authorized public institutions and private persons within the scope of data processing conditions regulated in Articles 5 and 6 of the Law, in accordance with the rules regarding the transfer of personal data specified in Article 8 of the Law.

Means, Purposes and Legal Basis of Collection of Your Personal Data

Your personal data is collected electronically through e-mail, SAP, Portal, fax, SRM system.

Your personal data is collected and processed by our Company for the following purposes and legal basis, based on the personal data processing conditions specified in Articles 5 and 6 of the Law.

Based on legal reason provided that it is directly related to enter into, or performance of, a contract, it is necessary to process the personal data of the parties to the contract and it is mandatory for the data controller to fulfill its legal obligations;

- To obtain and evaluate the necessary information for supplier application procedures,
- To negotiate in order to establish a supplier relationship with our Company,
- To enter into a supplier relationship between our Company and you or your employer,
- To fulfil the obligations arising from the supplier relationship between our Company and you or your employer,
- To register your user profile in the Türk Traktör Supplier Portal (“**Portal**”) created by our Company so that you can use the Portal on behalf of the relevant supplier, user management of the Portal, to record transactions carried out through the Portal,
- Execution of the payments.

Based on legal reason provided that it does not harm the fundamental rights and freedoms of the person concerned. Data processing is mandatory for the legitimate interests of the data controller;

- To enter into a supplier relationship between our Company and you or your employer,
- Audit processes of our Company,
- Corporate governance and sustainability activities of our Company,
- Management of legal processes.

Your Legal Rights

As the data subject, according to Article 11 of the Law have the right to;

- learn whether your personal data are processed or not,
- demand for information if your personal data is processed,
- learn the purpose of the processing of your personal data and whether personal data is used in compliance with the purpose,
- know the third parties to whom your personal data is transferred in Turkey or abroad,
- request the rectification of the incomplete or inaccurate data, and request notification to be made about rectification to third parties that personal data have been transferred to,
- request the erasure or destruction of your personal data (despite being processed under the provisions of Law on Personal Data Protection or other related laws, upon the disappearance of reasons which require process) within the scope of Article 7 of the Law and request notification to be made about this operation to third parties that personal data have been transferred to,
- object to the occurrence of a result against you by analyzing the data processed solely through automated systems,
- Claim compensation for the damage arising from the unlawful processing of your personal data.

You can submit your requests regarding these rights by filling out the "Application Form Regarding the Processing of Personal Data" and using the methods in this form available at <http://www.turktraktor.com.tr/en>. Your request will be concluded as soon as possible, and in any case within thirty (30) days at the latest, free of charge as a rule, but exceptionally if it requires an additional cost, against a fee in the rate determined by the Personal Data Protection Board.
